Three Prize Raffle

Official Rules

- 1) Tickets will be sold on a first come, first served basis to anyone 18 years of age or older. Members of Medina Volunteer Fire Department are NOT excluded from purchasing tickets. Award of any prize will be contingent upon the winner signing the Waiver of Liability and acknowledgement of who is responsible for any warrantee or product satisfaction issues
- 2) All State and Federal Laws apply.
- 3) 1000 tickets will be printed and numbered 000-999
- 4) The Drawing will begin within two weeks after all tickets are sold and will run for 3 consecutive weeks. **The winning numbers will be from the Texas Lottery Pick 3 numbers drawn at each of the three week's MONDAY 12:27 PM DRAWING.** There are only 1000 possible outcomes, and this is an independent tamper-proof selection process that guarantees one and only one winner each week. Prizes will be awarded in the following order: #1 LaCantera Resort Package, #2 Cabo San Lucas Fishing Trip and #3 Roxor ATV.
- 5) Tickets are \$60 each or two for \$100 and are entered into the drawing for each of the 3 consecutive weeks of the drawing. You keep the same number for all three and are eligible to win any time your ticket is drawn. Therefore, it is possible for the same number to be drawn more than once. There is no limit on the amount of tickets you may purchase.
- 6) Tickets may be purchased from a member of the MVFD, on the MVFD Website or at Medina Ace Hardware.
- 7) Winners will be notified using the information provided by winner on the ticket stub. Should the contact information provided be insufficient to contact the winner, the responsibility to monitor the weekly Pick3 drawings falls to the ticket holder. In addition to the Lottery's normal winning announcements, winning numbers will be posted on the MVFD Facebook page and MVFD Website. Failure to claim and/or schedule prizes within the time limits specified below will result in prizes being forfeited to the MVFD for future fundraisers. Exceptions will be made for members of the Armed Forces who are deployed and for any individuals restricted by government mandated limitations on travel.
- 8) **RAFFLE PRIZES in order of drawing:**
 - a) La Cantera Resort Package - winner will receive a gift certificate in the amount of \$1,500 and will have 14 days from drawing date to claim their prize after which the prize will be forfeited.
 - b) Cabo San Lucas Fishing Trip -winner will have 14 days from drawing date to claim their prize after which the prize will be forfeited. Award of this prize is conditioned upon the winner signing of a waiver of liability and responsibility. The trip must be scheduled within 1 year from the drawing date or be forfeited. Package will include transportation from airport to lodging, 4 nights

in a 3 bdrm/2bath condo in gated community, 2 days deep sea fishing for 6, one day ATV Safari and guided surf fishing for 6. This prize consists of two activity packages purchased by MVFD from 3rd party vendors. Any issues that may arise are between the prize winner and the vendor. MVFD will have no responsibility to resolve those issues. NOT INCLUDED in this prize are airfare, meals, beverages or other entertainment or tips for your guides.

- c) 2019 Roxor All-Terrain Vehicle (New) - winner will have 14 days from the drawing date to claim their prize after which the prize will be forfeited. The vehicle is new and stored inside but has been trailered to various events for raffle ticket sales. It will be "As is Where is" with no guarantees beyond the manufacturer's warrantee. ROXOR must be picked up at the MVFD facility in Medina as soon as possible.
